Who is processing my data?

Elite Pipeline, 4 Fonmon Park Road, Rhoose, Barry, Vale of Glamorgan, CF62 3BF, are the data controller and processes your personal information for the purposes laid out in this privacy notice.

The personal data that we collect is:

- Collect specific personal data (name, address, email, contact number) required to enter into a contract to sell a product or service.
- Engage in communication with you, including confirmation and reminders of appointments and requests to cancel or change services.
- Ensure a safe service and provide industry standard advice.
- Select relevant offers, promotions and information for you.
- Estimate the number of customers we have.
- Hold personal data required by law or to respond to legal processes.
- Hold for insurance purposes
- Store customer records.

Your rights as the individual

If Elite Pipeline holds your data, you have individual rights over it.

Where you have provided consent for us to contact you as part of our marketing services, you have the right to modify or withdraw your consent at any time by using the unsubscribe option accompanied with all of our direct marketing or by contacting the Elite Pipeline Data Officer.

You also have the right:

- Be informed of how your data will be used before it is collected.
- To access your data and to information on how your information is used after it has been gathered.
- To have personal data corrected if it is incomplete, inaccurate or out-of-date.
- To request the removal or deletion of personal data where there is no compelling reason for its continued processing.
- To restrict processing, to 'block' processing of your data.

Special categories of personal data collected

Your privacy is very important to us; we only use this information to determine your needs.

Process of collection

Your data is collected when you provide it to us, our website, over the phone, at Elite Pipeline, by email, social media, in writing or by any other means you provide to us. Information is stored digitally as well as some level of paper record keeping.

Data Sharing

Elite Pipeline does not share your personal information with any third party without your consent other than those already disclosed in this privacy policy or as part of our legal obligations under the relevant data protection laws.

Use of Data Processors

Data processors are third parties who provide some elements of our business services. Where we use a third party, we have strict agreements governing the processing of your data, on which no action can be taken without instruction from us. The third parties with whom we work will never share or disclose your personal information and will always hold it securely.

How Long Do We Keep Your Data?

Elite Pipeline retains your data for as long as necessary to provide you with our services as our client. Elite Pipeline is required under tax laws to keep your data for a minimum of 7 years.

- The criteria for which we would continue to process your personal information include the following:
- Where there is a legal basis, obligation or legitimate interest to continue processing your personal information
- Where the processing is necessary for the establishment, exercise or defence of legal Claims
